**Liters Dispensed Off-Premises For Samples And Tastings At ABC Licensed Retailers From Primary Manufacturing Premises:** The total liters of wine dispensed off-premises at ABC Licensed Retailers for samples and tastings reported on Form WM-7, Class II, Greater Than 16.5% ABV.

**Liters Sold On-Premises To Consumers For Off-Premises Consumption And Delivery Service Sales At Primary Manufacturing Premises:** The total liters of wine sold on-premises to consumers for off-premises consumption and delivery service sales at the primary manufacturing premises reported on Form WM-8, Class II, Greater Than 16.5% ABV.

**Liters Donated To ABC Licensed Nonprofit Special Events From Primary Manufacturing Premises:** The total liters of wine donated to ABC Licensed Nonprofit Special Events reported on Form WM-9, Class II, Greater Than 16.5% ABV.

**Liters Sold By Wine Festival Participants:** The total liters of wine sold or sampled by wine festival participants at licensed wine festivals reported on Form WM-15, Class II, Greater Than 16.5% ABV.

**Liters Sold To Retailers (Small Farm Wineries Only):** The total liters of wine sold to retailers as reported on Form WM-16, Class II, Greater Than 16.5% ABV. *Only wine manufacturers with a Small Farm Winery license designation are allowed to sell directly to retailers per ALABC Regs 20-X-8-.01(3).*

**Liters Dispensed To Consumers On-Premises At Off-Site Tasting Room:** The total liters of wine sold, sampled, and tasted on-premises by consumers for on-premises consumption at the off-site tasting room reported on Form WM-18, Class II, Greater Than 16.5% ABV.

**Liters Sold On-Premises To Consumers For Off-Premises Consumption At Off-Site Tasting Room:** The total liters of wine sold on-premises to consumers for off-premises consumption at the off-site tasting room reported on Form WM-19, Class II, Greater Than 16.5% ABV.

**Total Taxable Liters:** Total of all entries above. Total liters dispensed at primary manufacturing premises and off-site tasting room. This total is the number of liters used to calculate tax due.

**Tax Due On Taxable Liters:** Total Taxable Liters multiplied by \$2.42 (tax per liter).

**Other Adjustments:** The licensee must seek prior approval from the ABC Board.

**Total Tax Due:** Taxable Liters plus Other Adjustments.

**Signature:** Preparer or owner must sign the report.

Monthly Stock Report of In-State Manufacturer of Wine is to be included with the Monthly Tax Return of In-State Manufacturers of Wine and must be filed prior to the fifteenth day of the month following the month of production and/or sale of wine products. [20-X-9-.04]

**License Number:** Complete license number assigned by the ABC Board. (Example: 800-000123456. The complete license number is the type ("800") and the 9 digits shown as the license number.)

**Manufacturer Name:** Trade name as listed on your license issued by the ABC Board.

**County:** The county where the manufacturer is located.

**Reporting Period:** Month and year of period reported.

**BODY OF REPORT**

**Quantity:** State each package size separately. State containers per case and size (e.g., liters, ounces). Refer to the standard sizes for alcoholic beverages prescribed by the U.S. Treasury Department for guidance. Columns may be added as needed.

**Sales To Wine Wholesalers:** The total number, by size, sold to licensed wholesalers. Sales to Wine Wholesalers should be consistent with information reported on WM-4, Class II, Greater Than 16.5% ABV.

**Sales To Retailers (Small Farm Winery Only):** The total number, by size, sold to licensed retailers. Sales to Retailers should be consistent with information reported on WM-16, Class II, Greater Than 16.5% ABV. *Only wine manufacturers with a Small Farm Winery license designation are allowed to sell directly to retailers per ALABC Regs 20-X-8-.01(3).*

**Sales To ABC Board:** The total number sold to the ABC Board for each package size. Sales to ABC Board should be consistent with information reported on WM-5, Class II, Greater Than 16.5% ABV.

**Product Shipped To Alabama Residents (Direct Wine Shipper Licensees Only):** The total number, by size, shipped to Alabama Residents. *Only wine manufacturers with a Direct Wine Shipper license are allowed to ship to Alabama residents per ALABC Regs 20-X-5-.18.*

**Product Used For On-Premises Consumption Sales And Samples/Tastings At Primary Manufacturing Premises:** The total number, by size, used to provide for sales to consumers for on-premises consumption; or for samples and tastings. Product Used for On-Premises Consumption Sales and Samples/Tastings at Primary Manufacturing Premises should be consistent with information reported on WM-6, Class II, Greater Than 16.5% ABV.

**Product Sold On-Premises For Off-Premises Consumption And Delivery Service Sales At Primary Manufacturing Premises:** The total number, by size, used to provide for sales to consumers for off-premises consumption and delivery service sales. Product Sold On-Premises for Off-Premises Consumption and Delivery Service Sales at Primary Manufacturing Premises should be consistent with information reported on WM-8, Class II, Greater Than 16.5% ABV.

**Product Used For Off-Premises Samples/Tastings At ABC Licensed Retailers:** The total number, by size, used to provide for samples and tastings. Product Used for Off-Premises Samples/Tastings at ABC Licensed Retailers should be consistent with information reported on WM-7, Class II, Greater Than 16.5% ABV.

**Product Donated To ABC Licensed Nonprofit Special Events:** The total number, by size, used to provide for donations to ABC Licensed Nonprofit Special Events. Product Donated for ABC Licensed Nonprofit Special Events should be consistent with information reported on WM-9, Class II, Greater Than 16.5% ABV.

**Product Used/Sold At Wine Festival:** The total number, by size, used to provide for sales to consumers for on-premises consumption, samples and tastings, and off-premises consumption at wine festivals. Product Used/Sold at Wine Festival should be consistent with information reported on WM-15, Class II, Greater Than 16.5% ABV.

**Transfer In Bond Shipped:** The total number of contracted wine transferred out during the month, by units. Transfer In Bond Shipped should be consistent with information reported on WM-13, Class II, Greater Than 16.5% ABV.

**Transfer To Off-Site Tasting Room:** The total number, by size, of wine produced at primary manufacturing premises transferred to the off-site tasting room. Transfer to Off-Site Tasting Room should be consistent with information reported on WM-14, Class II, Greater Than 16.5% ABV.

**Export Sales:** The total number of sale/shipment, by size, that is shipped out-of-state. Export Sales should be consistent with information reported on WM-10, Class II, Greater Than 16.5% ABV.

**Package Conversion:** The total number being converted into another packaging configuration. This row should always balance (e.g., -4(1/2bbl) should be offset by +12(1/6bbl)). The net volume should always be zero for this row.

**Spoilage/Verified Breakage:** This row is used for items classified as depletions of inventory including expired wine, breakage, etc.; and is for inventory control purposes. Enter the totals by size. Spoilage/Verified Breakage should be consistent with information reported on WM-11, Class II, Greater Than 16.5% ABV.
